5. Plan & Profile Sta. 112+00 to 118+00 Main Street Sheet, Page 10 of Plans

See attached Plan & Profile Sta. 112+00 to 118+00 Main Street Sheet (1 Reduced Page) reflecting the **removal of three Construction Note 27 "Connect to Existing Waterline"** (**shown in revision clouds**). The work required to switch over the three service connections are covered by other bid items. Also, **Construction Note 17 and 24 were revised (shown in revision clouds).** Construction Note 17 was revised to include the installation of storm water curb openings (Neenah R-3262-3 with 4" ID Outlet) as shown on the bid form. Construction Note 24 was revised to clarify the Contractor is to install new water meter/valve. The Village is to supply material only.

6. Federal Davis Bacon Wage Rates

The Federal Davis Bacon Wage Decision was revised on May 9, 2014. All bidders are required to use the revised Davis Bacon Wage Decision for this project, see attached.
