

## NOTICE TO BIDDERS

Sealed bids for the Village of Woodstock, Main Street Reconstruction Project will be received by the Village at the Municipal Building, 101 North Main Street, P.O. Box 134, Woodstock, Ohio, 43084, until 11:00 a.m. local time, Friday, May 3, 2013, at which time and place they will be publicly opened and read aloud. The outside of the envelope shall be marked PROJECT BID: Village of Woodstock, Main Street Reconstruction Project

#### **GENERAL PROJECT DESCRIPTION FOR MAIN STREET RECONSTRUCTION PROJECT:**

Reconstruct approximately 550 feet of State Route 559 (Main Street within the Village) raising the grade. Install asphalt concrete pavement, curb and gutter, and sidewalk. Construct drainage improvements including approximately 300 feet of 30-inch Type C conduit and 12 drainage structures. Regrade approximately 300 feet of abandoned Railroad embankment which may be used as a borrow area. Restore all disturbed areas.

The Village reserves the right to accept or reject any or all bids or waive any irregularities. Copies of the Specifications are on file and available at the office of Kramer & Associates, LLC, 101 North Barron Street, Eaton, Ohio 45320 and may be obtained upon payment of \$50.00, none of which will be refunded. An additional non-refundable handling charge of \$10.00 per set is required if documents are to be shipped. Checks shall be made payable to Kramer & Associates, LLC. Proposals will only be accepted from bidders who have obtained Contract Documents (including plans and specifications) from Kramer & Associates and have been registered as a plan holder. The Village will conduct a non-mandatory pre-bid meeting at the Municipal Building on Friday, April 26, 2013 at 10:00 a.m. Prospective bidders are requested to submit your questions prior to the meeting at the email address above. Responses to the questions will be documented by Addendum which will be transmitted to all Plan Holders of Record. The abandoned railroad right of way will be accessible to interested parties upon 48-hours' notice submitted as above.

Each bid must be accompanied by either a bid bond in an amount of 100% of the bid amount with a surety satisfactory to the aforesaid Village of Woodstock, or by certified check, cashiers check, or letter of credit upon a solvent bank in the amount of not less than 10% of the bid amount in favor of the aforesaid Village. Bid bonds shall be accompanied by Proof of Authority of the official or agent signing the bond. A payment bond and a performance bond in the amount of 100% of the contract will be required upon the awarding of the Contract. The proposal must be made on the forms provided in the contract documents with a price quoted for the work.

Funding for this project comes from both the Ohio Public Works Commission and the Village of Woodstock. Payment to the contractor for contract work will be proportioned and sent directly from each funding source.

Each Proposal must contain the full name of the party or parties submitting the proposal and all persons interested therein. Each bidder must submit evidence of its experience on projects of similar size and complexity.

All contractors and subcontractors involved with the project will, to the extent practicable, use Ohio products, materials, services, and labor in the implementation of the project. Additionally, contractor's compliance with the equal employment opportunity requirements of Ohio Administrative Code Chapter 123, the Governor's Executive Order of 1972, and Governor's Executive Order 84-9 shall be required.

Bidders must comply with the prevailing wage rates on Public Improvements in Champaign County and the Village of Woodstock, Ohio as determined by the Ohio Department of Commerce Division of Labor and Worker Safety Wage and Hour Bureau, (614) 644-2239.

No Bidder may withdraw his bid within (30) days after the actual date of the opening thereof.
