

## NOTICE TO CONTRACTORS

The County of Preble through its Board of County Commissioners, will receive sealed proposals for the following in the Village of Camden:

### **GENERAL DESCRIPTION:** Camden – West Hendricks Street Improvements

Material Bids to supply materials only (HDPE storm pipe) for the West Hendricks Street Improvement project in accordance with the State of Ohio MBE set aside rules and regulations.

Project is located on West Hendricks Street, west of U.S. 127 and runs from the intersection with S.R. 725 east to Douglas Street. Removal of existing brick ditch and concrete curbs, installation of curb and gutter, installation of storm sewer & storm inlets, pavement widening, new asphalt surface course.

Bidders may bid on one scope or the other or both scopes.

Sealed Bids will be received until Monday, April 27, 2009 at 11:30 a.m., local time, at the Office of the Board of Preble County Commissioners, 101 East Main Street, Eaton Ohio, 45320, at which time and place they will be publicly opened and read aloud.

Copies of the Plans and Specifications, the estimated quantities of the items of work, the proposal and the contract forms are on file in the Office of the Board of Preble County Commissioners where they may be obtained upon the payment of \$50.00, none of which will be refunded. Please make your check payable to Kramer & Associates, LLC.

Each proposal shall be signed by the full name and business address of each person or company interested in the same, and shall be accompanied by a surety bond by a bonding company authorized to do business in the State of Ohio or by a certified check, cashier's check or letter of credit from some solvent bank. The bid guarantee bond shall be for the full amount of the bid and the certified check, cashier's check or letter of credit shall be equal to ten (10%) percent of the amount of the submitted proposal. The surety bond, certified check, cashier's check or letter of credit shall be payable to the Board of Preble County Commissioners as a guarantee that if the proposal is accepted, a Contract will be entered into and its performance properly secured by a satisfactory bond in the amount of one hundred (100%) percent of the contract price. All provisions of the Ohio Revised Code as it relates to bid guarantees, conditions, liabilities and withdrawal of a bid shall be adhered to by the Contractor.

The proposal must be made on the forms provided in the contract documents, or a copy thereof, with a price quoted for the work.

This project must use the Federal Davis Bacon wages included with the bid packet.
