

NOTICE TO CONTRACTOR

The County of Preble through its Board of County Commissioners, will receive sealed proposals for the following in the Village of Gratis:

GENERAL DESCRIPTION: Gratis – East Street Neighborhood Improvements Project

Reconstruct East Street (S.R. 122) from the intersection of Franklin Street south to Thomas Street (approx. 650 l.f.) and reconstruct the north walk and curb on South Street (approx. 200 l.f.), west of East Street. Project includes repair of existing deteriorated pavement and placement of asphalt to correct street cross section on East Street, removal and replacement of existing curb, and existing sidewalks, and construction of curb ramps along both sides of East Street and the north side of South Street, reconstruction of storm inlets and storm sewer and adjusting utilities as needed, and construction of 8" waterline on East Street, including replacement of fire hydrants and reconnection of water services.

Sealed Bids will be received until Wednesday, September 1, 2010 at 11:00.m., local time, at the Office of the Board of Preble County Commissioners, 101 East Main Street, Eaton Ohio, 45320, at which time and place they will be publicly opened and read aloud.

Copies of the Plans and Specifications, the estimated quantities of the items of work, the proposal and the contract forms are on file in the Office of the Board of Preble County Commissioners where they may be obtained upon the payment of \$50.00, none of which will be refunded. Please make your check payable to Kramer & Associates, LLC.

Each proposal shall be signed by the full name and business address of each person or company interested in the same, and shall be accompanied by a surety bond by a bonding company authorized to do business in the State of Ohio or by a certified check, cashier's check from some solvent bank. The bid guarantee bond shall be for the full amount of the bid and the certified check or cashier's check shall be equal to ten (10%) percent of the amount of the submitted proposal. The surety bond, certified check or cashier's check shall be payable to the Board of Preble County Commissioners as a guarantee that if the proposal is accepted, a Contract will be entered into and its performance properly secured by a satisfactory bond in the amount of one hundred (100%) percent of the contract price. All provisions of the Ohio Revised Code as it relates to bid guarantees, conditions, liabilities and withdrawal of a bid shall be adhered to by the Contractor.

The proposal must be made on the forms provided in the contract documents, or a copy thereof, with a price quoted for the work.

This project must use the Federal Davis Bacon wages included with the bid packet.
