GENERAL PROJECT DESCRIPTION FOR WATER SYSTEM INTERCONNECTION TO SOUTHWEST REGIONAL WATER DISTRICT PROJECT:

This project consists of work located in two areas (parts): (PART 1) Camden – West Elkton Road/Free Short Pike, 6" and 8" Waterline (10" under creek), including Metering Station; and (PART 2) Wayne Trace Road/Northern Road, 6" Waterline. This project is being administered by the Village of Camden, Ohio.

This project is to construct an interconnecting waterline between the water distribution systems of the Village of Camden and the Southwest Regional Water District (S.W.R.W.D.). The interconnect includes approximately 16,000 feet of new waterline, and includes bores at a creek and two bores for road crossings.
